A Red Cross certified swim program will be conducted in two three-week sessions. Classes will be scheduled between 11 A.M. and 4 P.M. Monday through Friday within the dates listed above. Each student will be scheduled for one 25-30 minute class (some advanced classes may run 40-45 minutes) per day. NOTE: Classes may not run the full time in the water--especially when the weather or water is cold! Some classes may be cancelled due to poor weather. Contact the Town Office (647-8786) if there is any question. The beaches will be posted when lessons are cancelled. NO LESSONS ON JULY 4.
